Directions for Use

For use on Golf, Lawns, and Sports Turf.

Apply 7.5 lbs. per 1000 sq. ft. This gives .6 lbs of Nitrogen per 1000 sq. ft. and the full recommeded rate of AQM (3oz per 1000 sq. ft.).

General Information

Nature Safe: The 0.80% Water Soluble Nitrogen of Nature Safe 8-3-5 will provide green-up in 7-10 days. The 7.20% Water Insoluble Nitrogen will release for up to 7-8 weeks.

AQM: A combination of kelp extracts and soil wetting agents designed to encourage root development, relieve water deficit stress, and improve root zone hydration. AQM is easy to use and will not harm turf when used in accordance with product directions. When used as directed, AQM can be applied at any time of the year to increase the vigorous appearance of turfgrass. AQM is safe to turf when used as recommended. Non Phytotoxic when used as directed.
